GOVERNOR'S WORKFORCE INNOVATION DIRECTIVE NO. PY2014-12, Change 02

SUBJECT: State Reporting/Technical Assistance Guide for WIOA

- 1. <u>Purpose.</u> This Directive transmits the most recently (July 16, 2015) revised page Attachment A (Appendix A (A-1)) of the *State Reporting/Technical Assistance Guide for WIOA*, which contains the income chart to be used in determining whether individuals meet the low income criteria of Title I of the Workforce Innovation and Opportunity Act (WIOA).
- 2. <u>Discussion.</u> The Employment and Training Administration issued incorrect income levels for the South Metro area when the income levels were initially published on March 27, 2015. On July 16, 2015, the ETA published the corrections in the Federal Register, Vol. 80, No. 136 for the South Metro 2015 Adjusted 70 Percent LLSIL and for Table 4 (corrected) 70 Percent of updated 2015 Lower Living Standard Income Level (LLSIL) by Family size. Only the South Metro (for our area) was affected by the new revision. Non-Metro was not affected. Please note that the Non-Metro data issued per GWID No. PY2014-12 is still valid. This income chart is to be used to determine low-income only. It is not to be confused with the issuance of the self-sufficiency income chart. The initial issuance and this correction are effective March 27, 2015.

These provisions in WIOA pertaining to LLSIL reflect no change from the prior language under the Workforce Investment Act of 1998, as amended.

3. <u>Action.</u> Please replace the previously transmitted page (revised) Attachment A (A-1) in the *State Reporting/Technical Assistance Guide for WIOA* with this most recently revised Page A-1 attached to this Directive. Subrecipients and staff should ensure that their respective eligibility certification staff uses the most recently revised income chart in determining whether individuals meet the low income criteria.

These guidelines go into effect on the day they were published, March 27, 2015. Any (Metro) participants evaluated based on the prior Lower Living Standard Income Level (LLSIL) amounts on or after March 27, 2015, whose level of service was affected, may be re-evaluated to ascertain their eligibility status based on the revised (July 16, 2015) data.
