GOVERNOR'S WORKFORCE INNOVATION DIRECTIVE NO. PY 2017-07, Change 6

SUBJECT: Program Year 2018/Fiscal Year 2019 Workforce Innovation and Opportunity Act (WIOA) Adult, Youth, and Dislocated Worker Allocations

1. **Purpose.** This transmits the State of Alabama's revised allocations for the Program Year (PY) 2018/Fiscal Year (FY) 2019 allotment.

2. **Discussion.** This Directive adjusts the funding levels for PY 2018/FY 2019 allotments for Adult, Youth, and Dislocated Worker programs under the WIOA Title I Section on recapture and re-allotment. For Program Year 2018, three (3) Local Areas had unobligated funds as of June 30, 2020, the end of the allocation period. Therefore, the State has recaptured a total of \$2,637,472.22 from PY 2018 / FY 2019 funding from these Local Areas and reallocated those funds to the remaining four (4) eligible Local Areas, as required by 20 CFR 683.110 (c)(2)(ii).

Please note that the amounts shown in Attachment 1 reflect recaptured funds only. Local Areas 1, 3, 6 and 7 should complete a change to their respective PY2018 plans. Recaptured funds should be listed on a separate WIOA-60 form, and the amount of recaptured funds should be added to the amount of previously award funds to show the total amount of funds awarded on the WIOA-59 form. Recaptured funds awarded to the four (4) Local Areas **must be expended no later than June 30, 2021**.

3. **Action.** This directive requires a plan change. Please revise your plan to incorporate the changes to your allocations and submit your revised plans to the Workforce Development Division by **December 17, 2020**. Please retain the Attachments for future reference.
